### **Notice Inviting Tender for Supply, Delivery, Installation, Commissioning and Maintenance of Medical Equipment / items at Ramakrishna Mission TB Sanatorium, Dungri, Tupudana, Ranchi - 835221**

Ramakrishna Mission Tuberculosis Sanatorium (hereinafter referred to as **RKMTBS**), Tupudana, Ranchi seeks tenders from original equipment manufacturers (OEM) or distributor/dealers with experience and at least three years of market standing as a supplier of Hospital Medical Equipment to supply, deliver, install, commission, and maintain the following medical equipment for its hospital:

- a) **One Allengers HF 59SR PLUS DIGISCAN COMPACT-SR** with 3 Years warranty
- b) **One PRORAD ATLAS Ultra-Portable Digital X-Ray System** with 3 years warranty
- c) **One Dental X-ray VATECH Oral Pantograph (OPG) unit VATECH PAX-i- PLUS** with HP System, Online Ups, EZ Cam, Di com Printer, Two Lid Apron with 5 years warranty
- d) **One Adult Cardiac Probe for the SonoRad V10 TRIVITRON Ultrasonography machine** with 1 year warranty

#### **Criteria for Eligibility of Bidders:**

1. The bidder must be a producer or distributor/dealer with experience delivering hospital equipment (to be substantiated / verified).
2. The bidder must have at least 3 (Three) years of market standing as a supplier of hospital medical equipment (to be substantiated / verified).
3. The bidder's annual revenue from medical equipment sales in FY 2023-24 shall be equivalent to or greater than the quoted price, as validated by CA with UDIN No. (to be substantiated / verified).
4. Bidder must supply a valid GST registration certificate with the bid.
5. Bidder must produce GST 3BR Return as of March 31, 2023-24.
6. The bidder should have experience packaging, distributing, and transporting medical equipment in all-weather situations.
7. Bidders who have been blacklisted by the Tender Inviting Authority, State Government, or Central Government Organization are not eligible to participate in the tender during the period of blacklisting Notarized Affidavit. The Notarized Affidavit must be provided.
8. The bidder must provide RKMTBS with all spare components needed for proper installation, commissioning, and handover of the equipment at no additional cost. During the warranty period, all software updates required for the equipment/instrument/machine will be provided free of charge. (This list is not exhaustive.)
9. **Purchaser's Right to Accept or Reject Any or All Bids:** RKMTBS maintains the right, at any point before the contract is awarded, to accept or reject any bid, to void the bidding process, and to reject all bids, all without incurring any liability to the affected bidder or bidders, or to have to notify the affected bidder or bidders of the reasons behind the purchaser's action. RKMTBS is not required to take any bid, much alone the lowest.

**Tender Fee:**

A *non-refundable* Tender Document Fee of Rs. 1000/- (Rupees One Thousand only) shall be applicable, which can be submitted in the form of Demand Draft in favour of **“Ramakrishna Mission TB Sanatorium”** payable at **Ranchi**.

**Payment Terms:**

- **First Instalment:** 20% of the supply order price will be released upon successful delivery of equipment at site with original GST invoice (two copies) and no physical damage.
- **Second Instalment:** 30% of the supply order price will be released after successful installation, commissioning, and handover to RKMTBS.
- **Balance:** The remainder amount will be released after successfully operating the equipment for four weeks (28 days) after handing it over to RKMTBS.
- Bidder to provide the Bank account details for release of fund through on-line transfer by RKMTBS.

**Delivery Schedule:**

- The successful bidder must promptly send medical equipment/items to Ramakrishna Mission TB Sanatorium, Dungri, Tupudana, Ranchi, 835221 within 30 days of RKMTB's releasing the supply order.
- Further, the bidder must complete the installation and commissioning of medical equipment/items at Ramakrishna Mission TB Sanatorium, Dungri, Tupudana, Ranchi, 835221 within 45 days of RKMTBS's supply order issuance.

**Deadline for Submission of Tender:** **The last date of submission of tender is up to 4.00 PM on October 7, 2024**
